4) **Public Hearing on Proposed Budget FY2019**

Pursuant to A.R.S. 48-805 and 48-807, The Avra Valley Fire District through its Board of Directors, has prepared an annual budget that contains detailed estimated expenditures for the fiscal year and clearly shows salaries payable to employees of the District, including the Fire Chief. In accordance with State statute, the *FY19 Proposed Budget* was posted in four public places and on the District's website for twenty days prior to holding this Public Hearing for the purpose of adopting said budget. Copies of the budget have also been made available to members of the public upon written request to the District. Following this second Public Hearing, the District Board may adopt the budget, whereafter a complete copy of the *FY19 Adopted Budget* shall be posted in a prominent location on the District's official website within seven business days and shall be retained on the website for at least sixty months.


Motion carried unanimously, 4:0.


- 8) **Adjournment**
